Class 1 Mini 70-75cm Team & Individual Qualifier (Riders to be aged under 14 on 1st January 2020) Single phase. All team riders automatically count as individuals.

Class 2 Novice 80-85cm Team & Individual Qualifier Single phase. All team riders automatically count as individuals.

Class 3 Intermediate 90-95cm Team & Individual Qualifier. Single phase. All team riders automatically count as individuals

Class 4 1m-1.05 Open Team & Individual Qualifier Single phase. All team riders automatically count as individuals

Class 5a/b 1.10m Advanced Open Individual Qualifier Single phase. This class will be split into 5a) Horses, 5b) Ponies

Entry Fees – All classes £18

First Aid - £4 per rider per day

All entry fees paid by cheque incur a £1.50 processing fee.

General information

Please ensure that you do not muck out your horsebox onto the Car Park. Take all litter home with you. All dogs must be kept on leads at all times. Any dog mess must be cleared up. No dogs to be taken into arenas at any time.

> Outside assistance will not be tolerated- and could result in elimination. NSEA affiliated competitors only may warm up & compete horses on the show ground

All competitions, parents and representatives from every school must ensure that they act courteously to stewards and officials at all times. Most of them are volunteers and rudeness is not acceptable.

In the event of cancellation, your entry will be refunded on receipt of a sae, less £5 per cheque admin fee. Have a good day!

Passports- please present to secretary BEFORE unloading any horses. Horses/Ponies must comply with Beechwood EC's vaccination requirements. Those who don't will be ineligible to compete and asked to leave the centre for the biosafety of other animals. Refunds will not be given.

EQUINE FLU VACCINATION POLICY:

Horses to have received an initial course of 3 flu vaccinations within the correct time periods, followed by annual boosters within a 12 month period. As a minimum, horses may attend Beechwood after receiving the first two injections of the initial course. 7 clear days must lapse between inoculation and attendance.
