Entry Fee: £18.00 per competitor, per class + £3 per competitor First Aid Lunch is included in your entry fee for the competitors and 1 team manager. Additional lunches may be preordered or purchased on the day at a cost of £2.50.

Class 1 Novice 70-75cm Team & Individual Qualifier Single phase. All team riders automatically count as individuals.

Class 2 Novice 80-85cm Team & Individual Qualifier Single phase. All team riders automatically count as individuals.

Class 3 Intermediate 90-95cm Team & Individual Qualifier.
Single phase. All team riders automatically count as individuals
Classes 1-3 Team & Individual Qualifier for the National Championships at Keysoe

Class 4 1m-1.05 Open Team & Individual Qualifier Single phase. All team riders automatically count as individuals

Class 5a/b 1.10m Advanced Open Individual Qualifier
Single phase. This class will be split into 5a) Horses, 5b) Ponies
Distances will be shortened in combinations for the pony section. 1 round single phase
Classes 4 & 5 The top 2 teams & 4 individuals will qualify to compete at Hickstead (1st August 2019)
The top 2 teams & individuals also qualify for the National Championships at Keysoe
