**Class 3 Novice 80-85cm Team & Individual Qualifier**

All team riders automatically count as individuals

**Class 4 Intermediate 90-95cm Team & Individual Qualifier.**

All team riders automatically count as individuals

**Class 5 Open 1m-1.05 Team & Individual Qualifier**

All team riders automatically count as individuals

**Class 6ab Advanced 1.10 Individual Qualifier a) horses and b) ponies**
