- Class 1 Mini 70-75cm Team & Individual Qualifier** **£22**  
(Riders to be aged under 14 on 1<sup>st</sup> January 2020)  
All team riders automatically count as individuals.
- Class 2 Novice 80-85cm Team & Individual Qualifier** **£22**  
All team riders automatically count as individuals.
- Class 3 Intermediate 90-95cm Team & Individual Qualifier.** **£22**  
All team riders automatically count as individuals
- Class 4 Open 1m-1.05 Team & Individual Qualifier** **£22**  
All team riders automatically count as individuals
- Class 5ab Advanced 1.10 Individual Qualifier a) horses and b) ponies** **£22**  
Please state whether you are riding a horse or pony section of the class, as the class will be split.

# Returning to sport from April 2021

## HEALTH CHECKS

1. *If any competitor, or anybody in their household, is showing symptoms of Coronavirus or has tested positive in the past 2 weeks, they must not attend any NSEA event. On the morning of the competition, prior to departure, there should be the following simple health check conducted:*

1. *Take the temperature of everybody in the household. If anybody has a temperature of over 37.8 degrees, then please seek medical advice and do not attend.*
2. *Is anybody in the household quarantined because of foreign travel to a country which is not exempt? If so, please do not attend.*
3. *If anybody in the household has any of the following symptoms then please seek medical advice, and do not attend:*
  1. *A persistent cough;*
  2. *A loss of taste or smell;*
  3. *A temperature (see 1(1) above)*

2. *If any competitor lives, or stables their horse, in an area which has been made the subject of a specific geographical lockdown then please do not attend an event.*

3. *If the event is located within an area which is subject to specific conditions, we will review those, and may cancel an event at short notice if required to do so.*

4. *If the competitor's school is located in an area which is subject to specific conditions, even if the competitor lives outside that area, if they have physically attended the school in the two weeks prior to the competition, they should not attend.*

5. *For competitors who live near borders between England and Wales, or England and Scotland, please be mindful of the potentially differing rules once you cross a border, and familiarise yourself with those rules.*

## AT THE SHOW CENTRE

6. *One person per squad should take charge of ensuring social distancing to ensure that everybody keeps their distance. They should familiarise themselves with one-way systems and protocols specific to each venue which will be available. Regular reminders will need to be given as it is easy to forget things when both on, and off, a horse. Remember to avoid sharing equipment. Household groups - or bubbles - should be maintained when moving around and please follow show centre instructions. Check in advance, for example, to see what, if any, catering facilities are available and plan accordingly.*

7. *Avoid touching surfaces like jumps or rails, and follow instructions given by show centres.*

8. *No spectators or supporters will be permitted. Just one parent/carer per competitor is encouraged wherever possible.*

9. *Do not forget to use hand sanitiser on arrival. Show centres will be providing this, but if there are shortages it is obviously sensible to bring your own which should be used regularly. Practise good hand-hygiene as often as possible throughout the day; show centres will all have soap and hot water available.*

10. *Any person at the event who becomes unwell should immediately isolate with their household, and if necessary should seek medical attention from the Paramedic team in attendance at NSEA events. The household with the unwell person in should leave the show centre to return home.*

11. *Please do not stay longer than is necessary for the competition. ARRIVE, COMPETE, LEAVE, in order to minimise the number of people at a show centre at any one time. All results will be published online.*

## BREACHES OF THE PROTOCOL

12. *If breaches of this protocol are brought to the attention of show organisers, they will be permitted to demand the entire school's team leave the show centre, and may eliminate competitors. The NSEA will then consider whether to allow that school or competitor to compete in future competitions.*

13. *Facemasks need to be worn in crowded areas for the time being, including course walks..*

### Equivents UK Rules and Regulations – PLEASE READ THESE PRIOR TO ENTERING

1. The Show Organisation referred to in these Rules and Regulations shall hereinafter mean EquiventsUK. The competitions in this schedule will hereinafter be referred to as the Show. 2. The Show, Show Organiser, Volunteer and Officials do not accept liability for any accident, damage, injury, theft or illness to horses, riders, owners, spectators or any other person or property whatsoever. 3. The Show Organiser retains as it absolute discretion the right to decline or exclude or remove any person or animal from the show or future shows or return any entry fee without being required to assign reason or being liable for any compensation. 4. Competitions – The Show Organiser reserves the right to cancel, add to, or amend any of the competitions, as they think fit. 5. By entering a class you agree you are at a suitable and safe level of ability to compete in these competitions. 6. Smoking – Smoking is not permitted within any of the showground buildings or stables. 7. Collecting Ring - All warming up must be done in the designated collecting Rings provided. Persons found abusing horses on the showground may be asked to leave. **8. Refund of Entry will only be made before the closing date of the competition less a 20% handling fee. NO REFUNDS will be issued after the closing date under any circumstances.** 9. Cheques will not be accepted. 10. Vehicles – The Show Organiser reserves the right to remove any vehicle which is obstructing any access to or from the ground even if locked and unattended. The Show Organiser will not be liable for any injury, loss or damage occasioned by such removal. 11. Dogs – Dogs are permitted in the Lorry Park and car park only. They must be kept under control at all times. If, in the opinion of the Show Organiser, any person fails to control their dog/s they may be asked to leave the show ground. 12. Prize Givings – There will be no prize givings, ONE member from your school may collect rosettes. 13. Objections – Objections should be made in writing within 1hr of the incident taking place and be accompanied by a £50 deposit that will be returned if your objection is upheld. 14. Official Photographs – Any photographs taken at the show by the official photographer may be used by the Show Organiser for promotional purposes. Please indicate on your entry form if you do not wish to appear in photos used for promotional purposes. 15. First Aid – A total of £5 per competitor per day. 16. Vaccination Certificate – All horses at the show must have a current and valid certificate of vaccination against Equine Influenza. There will be random checking of certificates and any horse found without a valid certificate will be asked to leave the show ground. 17. Stallions – No person shall allow a stallion for which he/she is responsible as owner, lessee, authorized agent or rider to compete or be prepared to compete, in any class without taking adequate precautions to ensure other persons are not put at risk of injury. 18. Close of Entries – Entries will close on the official closing date. Should space be available late entries may be accepted.

**Entry to the show constitutes your agreement that you, and those associated to you agree with, and are bound by the rules in this schedule.**

### Your Responsibility

*All persons attending the event must take all reasonable precautions to avoid and prevent accidents and must obey instructions given by the Organiser or by officials and stewards on its behalf.*

*All competitors and those associated with their school are the responsibility of the Team Manager whilst at the competition*

The NSEA will not be held responsible for any financial loss incurred by the attendee as a result of a cancellation.
