All classes will be run in the large outdoor arena

- CLASS 1 MINI TEAMS AND INDIVIDUALS JwS Qualifier 70/75cms Single phase. All team riders automatically count as individuals
- CLASS 2 NOVICE TEAMS AND INDIVIDUALS JwS Qualifier 80/85cms Single phase. All team riders automatically count as individuals
- **CLASS 3** INTERMEDIATE TEAMS & INDVIDUALS JwS Qualifier 90/95cms Single Phase. All team riders automatically count as individuals.
- CLASS 4 OPEN TEAMS AND INDIVIDUALS JwS Qualifier 1m/1.05m Single Phase. All team riders automatically count as individuals
- CLASS 5 ADVANCED TEAMS AND INDIVIDUALS JwS Qualifier 1.10m Single Phase. All team riders automatically count as individuals

Entry Fee: £22 per round, to include first aid cover.

PRIZES - Rosettes 1st-6th for individuals and 1st-6th for teams.

ENTRIES - Only entries made on the official entry form and accompanied by full payment will be accepted. Entries will close on Monday 17th June 2019 and should be sent to the Entries Secretary NOT the school. There will be no refunds after the close of entries without a vet's or doctor's certificate and none at all after 20th June 2019. Cheques should be made payable to: ST MARY'S SCHOOL, CALNE.

DISCLAIMER OF LIABILITY

Neither the organisers, nor any person acting on their behalf accept any liability for any loss, damage, accident, injury or illness to horses, riders, spectators or any other persons or property whatsoever. The Organiser of this event has taken reasonable precautions to ensure the health and safety of everyone present. Anyone in breach of this will be asked to leave the premises.

NSEA RULES AS THEY APPLY TO THIS COMPETITION:

- 1) This competition is run in accordance to the NSEA General and Additional Rules 2018-19 (see NSEA website).
- 2) Body protectors are compulsory for JwS classes.
- 3) Crash hats and body protectors as per British Eventing Rules 2019 for XC, no fixed peaked J hats for JwS classes. Hair must be above collar length, long hair to be kept in place in a hair net.
- 4) No dogs allowed.
- 5) It is compulsory that horseboxes and trailers must NOT be mucked out on site.
- 6) All horses and ponies must be at least four years old.
- 7) In the event of cancellation, entry fees will be refunded minus £5 admin fee per rider.
 Withdrawals before the closing date (17th June 2019) will have their entry fees refunded on receipt of a vet or doctor's certificate. Withdrawals after the closing date are non-refundable, for whatever reason.
- 8) The judge's decision is final.
- 9) In the event of being oversubscribed, a ballot in line with the NSEA ruling will take place. If a ballot takes place, all schools will be notified if their entry is NOT successful.

For all classes please ensure that your hat is of a current, up to date standard.
