

# **ENTRIES**

Entries open 18th July Entries will be taken on a first come first served basis.

ENTRIES CLOSE 29th August at 6pm or earlier if full.

No entry is accepted without the payment.

Please state under 'Requests' part of entry form **the name of your school** and if you are travelling with another competitor and require similar times.

#### Withdrawals:

Refunds can only be made (less £5 for admin) if your space can be replaced by someone off the Waitlist before close of entries. After Close of entries, no refunds or transfers are allowed.

#### **START TIMES:**

Start times can be found on the Northern Equine Events Facebook Page or on the NSEA Website at least 2 days prior to the event.

\*\*\*NSEA sections, all riders must be registered with the NSEA and each school must provide a volunteer/volunteers to fence judge - please contact the organiser before the 15th August to confirm.

### **CONDITIONS of ENTRY and RULES:**

All schools & riders must be affiliated to NSEA

These horse trials will be run according to the rules of British Eventing, except where varied below and the making of an entry constitutes acceptance of those rules.

- \*Horses/Ponies must be 4 years of age or older
- \*Riders must be at least 11 years of age for 100 and 10 years of age for 90. There is no minimum age limit for 80
- \*Points won in B.E. events will not apply.
- \*Hard hats must be worn to BE/PC/RC standards and must be tagged with new Aqua Coloured Tag (2018 onwards)
- \*Body protectors must be worn when competing in the cross country phase.
- \*Competitors should wear medical arm bands if they have anything they need to disclose to paramedics in event of a fall.
- \*Any horse or pony, which is considered by a Judge or the Organisers to be too small for the jockey, unsound, unfit or unhealthy, will be excluded from further competition without any refund of entry fee.
- \*ATV's and motor-bikes are not permitted, unless specifically authorised by the Organisers.
- \*All dogs must be kept on short leads.

\*Paper numbers will be used, so each rider will require a bib to display the number.

**Abandonment:** In the event of abandonment £10.00 (or Northern Equine Event's having to cancel the event) will be retained from each entry.

<u>DRESSAGE:</u> Dressage tests are the British Eventing tests which are available to download for free from <u>www.britisheventing.co.uk/downloads.</u>

**COURSE WALKING:** The XC Course will be open for walking from 6pm on the 2nd September.

**OBJECTIONS:** Objections must be made in writing to the Secretary within half an hour of the incident. Once Prize Giving has started, scores are final.
