Entries Close 19th November, or earlier if classes are full

Class 1 Mini 70-75cm Team & Individual Qualifier

(Riders to be aged under 14 on 1st January 2022)

Single phase. All team riders automatically count as individuals.

Class 2 Novice 80-85cm Team & Individual Qualifier

Single phase. All team riders automatically count as individuals.

Class 3 Intermediate 90-95cm Team & Individual Qualifier Plus Windsor Team Qualifier
Single phase. All team riders automatically count as individuals

Class 4 1m-1.05 Open Team & Individual Qualifier & Hickstead Elite Team Qualifier
Single phase. All team riders automatically count as individuals

Class 5a/b 1.10m Advanced Open Individual Qualifier & Hickstead Elite Qualifiers
Single phase. This class will be split into 5a) Horses, 5b) Ponies

Entry Fees classes 1 – 5 to include paramedic cover. £22 per horse/rider combination

These will be updated on 1st September 2021, at the start of the Autumn Term

HEALTH CHECKS

1. If any competitor, or anybody in their household, is showing symptoms of Coronavirus or has tested positive in the past 2 weeks, they must not attend any NSEA event. On the morning of the competition, prior to departure, there should be the following simple health check conducted:

1. Take the temperature of everybody in the household. If anybody has a temperature of over 37.8 degrees, then please seek medical advice and do not attend.
2. Is anybody in the household quarantined because of foreign travel to a country which is not exempt? If so, please do not attend.
3. If anybody in the household has any of the following symptoms then please seek medical advice, and do not attend:
 1. A persistent cough;
 2. A loss of taste or smell;
 3. A temperature (see 1(1) above)

Facemasks may need to be worn in crowded areas for the time being.
