Class 2B Novice 80-85cm Team & Individual Qualifier Single phase. All team riders automatically count as individuals.

Class 3B Intermediate 90-95cm Team & Individual Qualifier, including Windsor Team Qualifier Single phase. All team riders automatically count as individuals

Class 4B 1m-1.05 Open Team & Individual Qualifier Including Hickstead Elite team Qualifier Single phase. All team riders automatically count as individuals

Class 5a/b 1.10m Advanced Open Individual Qualifier including Hickstead Elite Qualifiers (2 x horses and 2 x ponies to qualify) Single phase. This class will be split into 5a) Horses, 5b) Ponies

COMBINED TRAINING Enter both A & B parts of a class for combined training
