Test: Prelim 1 - open to all

Entry Fee: £16

# **Team Qualifiers**

Teams (of 3 or 4, the best 3 percentage scores to count)

A horse/rider combination may only compete in one team.

# **Class 2 County Prelim Teams**

open to 3/4 x prelim riders that have never ridden above BD bronze prelim level, any novice level dressage (affiliated or unaffiliated,) open pony club or novice BE eventing.

Test: Prelim 12 (2005) revised 2016

The winning team from each respective county will represent their county at the NSEA Inter County Finals.

(2023 Inter-County Prelim Team Champions- Abbotsholme, Cheshire)

Entry Fee: £18 per rider

# **Class 3 County Open Teams**

(2 x prelim riders & 2 x novice riders)

Prelim section is open to horse & rider combinations that have not competed at British Dressage Elementary level or above. Novice section is open to all.

Teams of 3 / 4 riders, 3 scores to count

Test: Prelim 12 (2005) revised 2016 x 2 riders

Test: Novice 24 (revised 2016) x 2 riders

The winner from each respective county will represent their county at the NSEA Inter County Finals.

(2023 Inter-County Open Team Champions – Mayfield, East Sussex)

Entry Fee: £18 per rider

## **Class 4 County Individual Prelim Qualifiers**

Prelim 12

**4A** County Prelim Restricted Individual – Rider to have only competed at prelim level **4B** County Prelim Open level – open to all horse/ rider combinations who have not competed at Elementary level or above, or BE Intermediate level.

Entry Fee: £18 per rider

## **Class 5 County Individual Novice Qualifiers**

#### **Novice 24**

Open to rider/horse combinations not to have competed at BD Medium level or above or BE Intermediate level.

Entry Fee: £18 per rider

The winning individual from each respective county individual class will represent their county at the NSEA Inter County Finals (one per county only.)

If there are two sections per class, a ride off will determine the result.

#### **BURY FARM BIOSECURITY MEASURES**

All horses must be travelled with passports which can demonstrate that all vaccinations are up to date (Bury Farm operates a 12-month vaccination policy). Horses must also show no clinical signs of the following when attending the centre:

- 1. recent cough of unknown cause
- 2. recent nasal discharge of unknown cause
- enlarged lymph nodes
- 4. fever (>38.5 degrees)
- 5. recent onset of neurological signs of unknown cause
- 6. diarrhoea

#### Horses must also

- 1. not be under current investigation for EHV infection
- 2. have not been in contact with and is not kept on the same premises as a horse known to have or be under investigation for EHV
- 3. have not travelled out of the country for the past 28 days.

Horses should NOT be brought to the centre if they are not in good health on the date of travel.

#### **BURY FARM SHOW ETIQUETTE**

- 1. The decision of the judges & stewards in all cases is final. They reserve the right to alter, amend or cancel any part of the competition or to refuse any entry without stating a reason.
- 2. The organiser of this event has taken reasonable precautions to ensure the health, safety and welfare of everyone present. For these measures to be effective, everyone must take all reasonable precautions to avoid and prevent accidents occurring, and must obey instructions of the organisers, officials and stewards.
- 3. The organisers will not be held responsible and accept no liability for any accident, loss, damage, injury or illness to horses, owners, rider, spectators, vehicles or their contents and accessories, breach of contract or in any other way whatsoever. It is a condition of entry that each entrant shall agree to indemnify against any legal action arising from such incident.
- 4. All competitors must be suitably dressed in correct riding attire to current British Safety Standards. Riding / Jodhpur boots must be worn for all classes.
- 5. Horses & ponies tied to lorry or trailers must not be left unattended.
- 6. Please ensure the area around your horsebox / trailer is clean and tidy. Droppings collected and not swept onto or left on BFEC. Please take litter home or use the bins provided.
- 7. Children must be supervised at all times
- 8. Whilst outside arenas, horses and ponies should be moved at a walk only.
- 9. There is a vet on call. The expense of any veterinary services rendered either on or after the show must be borne by the competitor or owner of the horse / pony.
- 10. No dogs allowed, other than in Lorry Park Only and MUST be on a lead at all times

### Your Responsibility

All persons attending the event must take all reasonable precautions to avoid and prevent accidents and must obey instructions given by the Organiser or by officials and stewards on its behalf.
