Class 1 Mini 70-75cm Team & Individual Qualifier

(Riders to be aged under 14 on 1<sup>st</sup> January 2025)

Single phase. All team riders automatically count as individuals. £17.00

Class 2 Novice 80-85cm Team & Individual Qualifier

Single phase. All team riders automatically count as individuals. £17.00

Class 3 Intermediate 90-95cm Team & Individual Qualifier. £17.00

Single phase. All team riders automatically count as individuals

**Class 4 1m-1.05 Open Team & Individual Qualifier £17.00**  
Single phase. All team riders automatically count as individuals

**Class 5a/b 1.10m Advanced Open Individual Qualifier £17.00**  
( 2 x horses and 2 x ponies to qualify)  
Single phase. This class will be split into 5a) Horses, 5b) Ponies
