Class 1 Mini 70-75cm Team & Individual SJ Qualifier

(Riders to be aged under 14 on 1st January 2025)

Single phase. All team riders automatically count as individuals.

Class 2 Novice 80-85cm Team & Individual SJ Qualifier

Single phase. All team riders automatically count as individuals.

Class 3 Intermediate 90-95cm Team & Individual SJ Qualifier.

Single phase. All team riders automatically count as individuals

Class 4 1m-1.05 Open Team & Individual SJ Qualifier

Single phase. All team riders automatically count as individuals

Class 5a/b 1.10m Advanced Open Individual SJ Qualifier
(2 x horses and 2 x ponies to qualify)
Single phase. This class will be split into 5a) Horses, 5b) Ponies

Mixed Height Team SJ Qualifier
Teams of 3, all scores to count.
1 rider per height 1 x 70/75, 1 x 80/85 and 1 x 90/95 from classes 11, 12 & 13. No extra entry fee.

Class 11 Mini 70-75cm Team & Individual JWS Qualifier
(Riders to be aged under 14 on 1st January 2025)
Single phase. All team riders automatically count as individuals.

Class 12 Novice 80-85cm Team & Individual JWS Qualifier
Single phase. All team riders automatically count as individuals.

Class 13 Intermediate 90-95cm Team & Individual JWS Qualifier.
Single phase. All team riders automatically count as individuals

Class 14 1m-1.05 Open Team & Individual JWS Qualifier
Single phase. All team riders automatically count as individuals

Class 15a/b 1.10m Advanced Open Individual JWS Qualifier
(2 x horses and 2 x ponies to qualify)
Single phase. This class will be split into 5a) Horses, 5b) Ponies
